- All carrier manifests except POS, POM, and PON should be Closed and Printed.
- Carrier manifests for POS, POM, and PON should be Closed, Printed, and Opened for a New Day.

USPS Rate Update

The following changes have been implemented as a result of the 2020 USPS Rate Change which will take effect on January 26, 2020:

- The USPS will put into effect rate change increases for most services. This includes but is not limited to the following:
 - Parcel Select
 - Parcel Select Lightweight
 - First-Class Package
 - First-Class Mail
 - Priority Mail Express
 - Priority Mail
 - Retail Ground
 - Parcel Select Lightweight
 - Priority Mail International
 - Priority Mail Express International
 - First-Class Package International Service
- Extended dimensional weight pricing for Retail Ground from Zones 1-4 to Zones 1-8 to align with Priority Mail.
- · Cremated remains are now limited to:
 - Signature Required
 - Signature Waived
 - Return Receipt
 - Additional Insurance
- South Sudan has been added to the list of supported countries. Macedonia Republic has been changed to North Macedonia Republic.
- Various updates to the following Postage Statement forms:
 - 3600-PM
 - 3600-FCM
 - 3205-R
 - 3602-R
 - 3602-N
 - 3605-N
