THIS AMENDMENT TO PARTICIPATING ADDENDUM is by and between the State of Wyoming (Participating State), and Pitney Bowes, Inc. (Contractor).

WHEREAS, the Lead State has a Master Agreement with the Contractor/identified as ADSPO16-169897, effective May 15, 2017, through May 14, 2019 (the "~~Participating Addendum~~" as amended), to provide mail equipment, supplies and maintenance resulting from the NASPO ValuePoint Arizona Solicitation ADSPO16-00006328;

WHEREAS, the Participating State entered into a Participating Addendum (the "Participating Addendum") under the Master Agreement on December 5, 2017; and

WHEREAS, the terms of the Master Agreement specifically state that the Participating Addendum may be amended per agreement by both parties.

NOW, THEREFORE, it is agreed by the parties to amend the Participating Addendum as follows to be co-terminious with the Master Agreement Amendment Five:

1. This Master Agreement shall be effective from December 5, 2017, to May 14 2020, unless sooner terminated by either party as specified in the Master Agreement Contract Termination Clause (#9, page 88).

Terms and conditions inconsistent with, contrary or in addition to the terms and conditions of the Participating Addendum and the Master Agreement, together with its exhibits, shall not be added to or incorporated into the Participating Addendum or the Master Agreement and its exhibits, by any subsequent purchase order or otherwise, and any such attempts to add or incorporate such terms and conditions are hereby rejected. The terms and conditions of the Participating Addendum and the Master Agreement and its exhibits shall prevail and govern in the case of any such inconsistent or additional terms. The Participating Addendum applies only in the jurisdiction of the Participating State which has executed the Participating Addendum.


